Indoor Air Quality Tools for Schools 2011 National Symposium

The National Environmental Health Association, in cooperation with the United States Environmental Protection Agency (U.S. EPA), is offering a significant training opportunity for environmental health professionals working in city, county, or state health or environmental protection agencies, or for individuals who have been active with community groups working on school health and safety issues. U.S. EPA will host their 11th Annual Indoor Air Quality (IAQ) Tools for Schools National Symposium on January 13-15, 2011, at the Grand Hyatt Hotel in Washington, D.C. Building on last year's success, the symposium will bring together school board officials, administrators, nurses, teachers, facility managers, school and health association members, parents, and others to discuss the effects of indoor air quality in our nation's schools.

IAQ Tools for Schools is a nationwide initiative to help school officials assess, resolve, and prevent indoor air quality problems and reduce exposure to asthma triggers in school facilities. Innovative sessions will address various topics associated with implementing an IAQ program in a school setting, including communication strategies, mold remediation, facilities management, integrated pest management, new school construction, student performance, advocacy, financing, asthma management, and more. An awards ceremony will be held to honor schools with exemplary IAQ programs.

NEHA will select up to 13 people for training in Washington, D.C., with all expenses paid. This would include round-trip coach airfare, lodging at the Grand Hyatt Hotel, and a per diem allowance for meals. Travel to Washington, D.C. will be on Wednesday, January 12.

Saturday, January 15 (3/4 of a day)

- ◆ Any specialized IAQ Tools for Schools programs you are involved in or will develop.
- ◆ Any special areas of interest that you feel are relevant to your consideration for this course.
- ◆ How this symposium can help you initiate or increase implementation of the Tools for Schools kit.
- ◆ That you have the support of management to undertake and participate in a one-year IAQ Tools for Schools program.
