Membership Survey

To better understand the needs of our members, NEHA completed a survey of members who joined, or re-joined after a lapse in their membership, between 2018 and 2019. Survey results indicate the primary reason that members joined in the past two years was to pursue or maintain their environmental health credentials at both the national and state level.

Overwhelmingly, members conveyed that they find value in NEHA's online learning courses but would like to see improvements in both content and ease of access to these resources. 60% of the respondents cited e-learning as the benefit they would most like to see improved and expanded upon moving forward.
