Definitions of Equity



Definition of equity: "The consistent and systematic fair, just and impartial treatment of all individuals."




Environmental justice: fair treatment and meaningful involvement of all people regardless of race, color, national origin, or income, with respect to the development, implementation, and enforcement of environmental laws, regulations, and policies



Environmental justice: **fairness, regardless of race, color, national origin or income,** in the development of laws and regulations that affect every community's natural surroundings, and the places people live, work, play and learn.

Healthy Places Index


- Launched in 2018
- Maps emphasize social conditions (15 of 25 indicators)
- Provides extensive policy action guides that link to the data
- Census tracts are ranked for comparison
- An area with a high score is healthier

CalEnviroScreen

- Launched in 2013
- Maps emphasize environmental pollution and exposure (13 of 21 indicators)
- Maps by cumulative pollution or single indicator
- Census tracts are ranked for comparison
- An area with a high score experiences a much higher pollution burden
